PAYMENT CAN BE MADE IN ADVANCE BUT DOES NOT GUARANTEE SPACE WILL BE RESERVED FOR YOUR RV. SPACE IS AVAILABLE ON A FIRST COME FIRST SERVED BASIS. ALL PAYMENTS ARE NON-REFUNDABLE.
