THERE IS A \$60 CHARGE TO PARK AN RV IN THE CIVIC CENTER'S MAIN LOT. THIS CHARGE APPLIES REGARDLESS OF WHETHER OR NOT THE RV STAYS IN THE LOT OVERNIGHT. RVs STAYING TWO NIGHTS PAY \$120. THERE IS NO DISCOUNT FOR MULTIPLE NIGHTS.

PAYMENT CAN BE MADE IN ADVANCE BUT DOES NOT GUARANTEE SPACE WILL BE RESERVED FOR YOUR RV. SPACE IS AVAILABLE ON A FIRST COME FIRST SERVED BASIS. ALL PAYMENTS ARE NON-REFUNDABLE.
